CLUSTER'S MENTAL HEALTH RESIDENTIAL SERVICES PROGRAM ARE LICENSED THROUGH NYS OFFICE OF MENTAL HEALTH. THOSE PROGRAMS PROVIDE HOUSING AND SUPPORT SERVICES FOR INDIVIDUALS WITH CHRONIC MENTAL ILLNESS. MANY OF THE INDIVIDUALS WE SERVE HAVE BEEN HOMELESS, INCARCERATED OR HAVE EXPERIENCED LONG TERM HOSPITALIZATION. USING A PERSON-CENTERED TRAUMA INFORMED APPROACH; WE PROVIDE OPPORTUNITIES TO INDIVIDUALS TO ACHIEVE THEIR LIFE GOALS. OUR CLIENTS BENEFIT FROM THIS WITH STABLE HOUSING, DECREASED HOSPITALIZATIONS AND REDUCED RECIDIVISM. OUR 5TH PROGRAM IS UNLICENSED AND 91% OF THOSE SUPPORTED HOUSING PROGRAM RESIDENTS HAVE MAINTAINED INDEPENDENT HOUSING IN THE COMMUNITY FOR OVER 2 YEARS. WE PARTNER WITH THE COMMUNITY TO PROVIDE THERAPEUTIC WORKSHOPS WITH LOCAL ARTISTS, RECREATIONAL ACTIVITIES AND SUBSTANCE ABUSE GROUPS. TO

THROUGH A CONTRACT AWARDED TO THE CENTER FROM THE NEW YORK STATE UNIFIED COURT, MEDIATION IS OFFERED AS AN OPTION TO INDIVIDUALS AND FAMILIES FACING A CURRENT LEGAL DISPUTE IN PARTNERED SMALL CLAIMS AND FAMILY COURTS.
